Here is the list of approved motor oils for EDI warranty coverage for the Ford Industrial Gasoline Engines for 2025.

**1.0) For all ambient temperatures, Ford 2.5L (MSG425) 4-cylinder & Ford 3.7L (CSG637) 6 cylinder.**

API SP 5W20, ILSAC GF-6A, Ford Oil Specification **WSS-M2C960-A1, all temperatures.**

Motorcraft Oil part numbers, XO-5W20-Q1SP synthetic blend, XO-5W20-Q1FS full synthetic.

**2.0) For ambient temperatures down to -22F / -30C, Ford 3.5L (LSG635) 6-cylinder, Ford 5.0L (WSG850) 8-cylinder, Ford 6.2L (RSG862) 8-cylinder, Ford 7.3L (WSG873) 8-cylinder.**

API SP 5W30, ILSAC GF-6A, Ford Oil Specification **WSS-M2C961-A1 ambient temp to -22F/-30C ambient.**

Motorcraft Oil part numbers, XO-5W30-Q1SP synthetic blend, XO-5W30-Q1FS full synthetic.

**3.0) For ambient temperatures below -22F / -30C, Ford 3.5L (LSG635) 6-cylinder, Ford 5.0L (WSG850) 8-cylinder, Ford 6.2L (RSG862) 8-cylinder, Ford 7.3L (WSG873) 8-cylinder.**

API SP 0W30, ILSAC GF-6A, Ford oil Specification **WSS-M2C963-A1.**

Mobil 1 Advanced Fuel Economy API 0W30 SP full synthetic oil meets WSS-M2C963-A1.

**4.0) Synthetic Blend Vs Full Synthetic Oil Requirements.**

Both Motorcraft Full Synthetic (FS) motor oil and Motorcraft Synthetic Blend (SP) engine oils are approved for use and covered under the EDI warranty. The Synthetic Blend (SP) motor oil offers a more cost-effective oil supply for the Ford oil specification. Both Full Synthetic (FS) and Synthetic Blend (SP) require the same **documented** oil change intervals of 400 hrs for normal use, 350 hrs for severe use and 300 hrs for extreme use to receive EDI warranty coverage.

### 5.0) API Requirements for EDI Warranty Coverage.



The certified “For Gasoline Engines” American Petroleum Institute (API graphic) must be displayed on **ALL** oil containers used.

Motor Oil container must say “**Approved for**” or “**Meets the**” Ford Oil Specifications Listed “**WSS-M2C960-A1**” for the specific EDI Ford Engine defined above.

Motor Oil container must display the **API 5W30 SP** in addition to the **ILSAC GF-6A** for the specific EDI Ford Engine defined above.

Oil listing “Recommended for”, “Similar to”, “Suitable for”, or “Equivalent of” are **NOT** acceptable for EDI warranty coverage.

Do not use supplemental oil additives or other engine treatments. They are unnecessary and could, under certain conditions, lead to engine damage which is **NOT** covered by EDI warranty.
